From the President

Happy New Year! It is that time of year again when we focus on new beginnings and goals we want to accomplish in the new year. It is also a time of year when we think back on how much we accomplished in the previous year.

2024 was a big year for PAs in Tennessee. We were successful in achieving a much needed update to our practice act that decreases restrictions on PAs with 6000 hours of clinical experience, and we successfully joined the national PA Licensing Compact. I would like to give a few updates on both of these legislative wins and also point out that these accomplishments could not have happened without the support of PAs like you!

The legislation that allows Tennessee PAs to have an endorsement on their license if they have 6000 hours of clinical practice is currently having the details worked out by the taskforce and Tennessee Board of PAs. The taskforce is made up of three members from the PA licensing board, one member from the allopathic physician board, one member from the podiatric physician board, and one member from the podiatric physician board. We have already had one successful taskforce meeting and our next meeting is scheduled for Jan. 31st. We hope to have these collaboration agreement rules adopted soon so that the entirety of the bill will then be active. Please stay tuned to TAPA announcements for notifications of when that happens.

The PA licensing compact creation is in full swing as well. As the elected member that represents Tennessee on the compact, I now have full voting authority during the meetings. This is very important because I am currently only one of two PAs on the compact commission as other states have opted to send lawyers or administrative staff as their state representatives.

It is vitally important to me that PAs are well represented during the creation of the compact so that our profession is moving forward with its implementation. But as it stands now, PA voices that have voting authority are vastly outnumbered. While several of the lawyers and administrative staff chosen by their states have meaningful experience working on other professional licensing compacts (namely the allopathic physician one), in my opinion, it is still important for PAs to have a strong voice in the creation of such a huge addition to our profession.

Hopefully, as more states sign on to the compact, more PAs will be selected to represent their state. Currently there is one PA from Virginia that was voted onto the compact Executive Committee, and I serve on the Rules Committee and the Communications Committee.

We have had one in-person meeting as an entire group, and the rules committee has had two virtual meetings. We have an in-person meeting scheduled for Jan. 29, and this will the first meeting where I will be a voting member so I plan to attend in person.

TAPA continues to work tirelessly to push the profession forward in 2025. While we do not have any TAPA sponsored legislation this year, we will be watching closely to make sure there are no bills that are put forward by any other entities that could be detrimental to our profession. Regardless of whether we have our own legislation, TAPA is still planning a strong "PA Day on the Hill" on Feb. 19.

Last year, we had one of the best PA Hill Days in the entire country, with almost 300 people in attendance and more than 100 meetings scheduled. We also had tremendous positive media coverage, so it was a big day for PAs

PA Student of the Year: Jaydan Hull, PA-S and Allie Nakoff, PA-S

This year, there was a tie in the PA Student of the Year judging, so the committee decided to recognize both of these outstanding students.

Jaydan Hull is a student at Milligan University. She has worked very hard to have the opportunity to train as a PA. Prior to entering PA school, she worked as a certified nursing assistant to gain healthcare experience for her PA program application. She has demonstrated her passion for serving those in need by volunteering with Remote Area Medical clinics, Project CURE, Kids Against Hunger, and Coalition for Kids. She

also recently served on a short-term medical mission trip to Ecuador with several other Milligan PA students and faculty members.

Jaydan has participated in many roles and activities to further the image of the PA profession. Educator of the Year - Jennifer Rayburn, MD
